Each pound of this meal product contains 35 grams per pound of chlortetracycline and 35 grams per pound of sulfamethazine. The product carriers will enhance pellet quality. Pennchlor•S™ is an aid in the maintenance of weight gains in the presence of respiratory diseases such as shipping fever.

PRODUCT DESCRIPTION

Pennchlor•S™ contains chlortetracycline calcium complex equivalent to chlortetracycline HCl 35 grams per pound and sulfamethazine at 7.7% (35 grams per pound).

Ingredients—Calcium Sulfate, Dried Streptomyces aureofaciens Fermentation product, Mineral Oil.

Packaging—Pennchlor•S™ is available in 50 pound bags. Bags are fuchsia color-coded in gusset area.

Calcium Sulfate, Dried Streptomyces Aureofaciens Fermentation Product, Mineral Oil

MIXING DIRECTIONS:

Mix sufficient Pennchlor-S™ in the feed to supply 350 mg of Chlortetracycline and 350 mg of Sulfamethazine per head per day. The following table shows the amounts of Pennchlor-S™ needed for the various quantities of supplement.
